

It's getting to be that time of the year and just wanted to give some information about the Christmas Dinner.


The Christmas Dinner will be held on Thursday (not Wednesday) December 5, 2024 at 6:00 p.m.

Thank you so much to the ladies who volunteered to help with the set -up and serving of the meal, but many hands make light work and I would appreciate a couple more volunteers.


